



PART I – GENERAL INFORMATION

1. **Last Date and Time for Depositing the Bids:**

2. **Manner of Depositing the Bids:**

10. **Clarification Regarding Contents of the Bids.**

During evaluation and comparison of bids, the Buyer may, at its discretion, ask the bidder for clarification of his bid. This request for clarification will be given in writing and no change in prices or substance of the bid will be sought, offered or permitted. No post-bid clarification on the initiative of the bidder will be entertained.

11. **Rejection of Bids.**

Canvassing by the Bidder in any form, unsolicited letter and post tender correction may invoke summary rejection with disqualifying the firm from bidding for any contract for a period of one year from the date of notification. Conditional tenders will be rejected.

12. **Unwillingness to Quote.**

Bidder unwilling to quote should ensure that intimation to this effect reaches before the due date and time of opening of the Bid, failing which the bidder shall be de-listed for the given range of items as mentioned in this RFP.


13. **Validity of Bids.**

The Bids should remain valid for a period of 90 days from the date of opening of tender.

14. **Earnest Money Deposit.**

Bidders are required to submit Earnest Money Deposit for an amount of Rs 24,000/- (Rupees twenty four thousand only) along with their bids. The EMD may be submitted in the form of an Account Payee Demand Draft, Fixed Deposit Receipt, Banker Cheque or Bank Guarantee from any of the Public Sector Bank or a Private Sector Bank authorized to conduct government business. EMD is to remain valid for a period of thirty days beyond the final technical validity period. EMD of the unsuccessful bidders will be returned to them at the earliest after expiry of the final bid validity and latest on or before 30th day after the award of the contract. The Bid security of the successful bidder would be returned, without any interest whatsoever, after the receipt of performance security from them as called for in the contract. The EMD will be forfeited, if the bidder withdraws or amends, impairs or derogates from the tender in any respect within the validity of the tender.





PART-III: STANDARD CONDITIONS OF RFP

THE BIDDERS ARE REQUIRED TO GIVE CONFIRMATION OF THEIR ACCEPTANCE OF THE STANDARD CONDITIONS OF THE REQUEST FOR PROPOSAL MENTIONED BELOW WHICH WILL AUTOMATICALLY BE CONSIDERED AS PART OF THE CONTRACT CONCLUDED WITH THE SUCCESSFUL BIDDER (I.E SELLER IN THE CONTRACT) AS SELECTED BY THE BUYER. FAILURE TO DO SO MAY RESULT IN REJECTION OF THE BID SUBMITTED BY THE BIDDER

1. Law.

The contract shall be considered and made in accordance with the laws of the Republic of India. The contract shall be governed by and interpreted in accordance with the laws of the Republic of India.

2. Effective Date of the Contract.

The contract shall come into effect on the date of signature of both the parties on the contract agreement and shall remain valid till the completion of the obligation of the parties under the contract. The deliveries and supplies and performance of the services shall commence from the effective date of the contract.

3. Arbitration.

All disputes or differences arising out of or in connection with the contract shall be settled by bilateral discussions. Any dispute, disagreement or question arising out of or related to the contract or related to construction or performance, which cannot be settled amicably, may be resolved through arbitration. The standard clause of arbitration is as per Forms DPM-7, DPM-8 and DPM-9 (Available in MoD website and can be provided on request).

4. Non-disclosure of Contract Documents.

Except with the written consent of the Buyer/seller, other party shall not disclose the contract or any provision, specification, plan, design, pattern, sample or information thereof to any third party.


5. Liquidated Damages.

In the event of the Seller's failure to submit the bonds, Guarantees and documents, supply the stores/goods and conduct trial, installation of equipment, training etc. as specified in this contract, the Buyer may, at his discretion, withhold any payment until the completion of the contract. The BUYER may also deduct from the SELLER as agreed, liquidated damages @ the sum of 0.5% of the contract price of the delayed/undelivered stores/services mentioned above for every week of delay or part of a week, subject to the maximum value of the Liquidated Damages not exceeding 10% of the value of delayed stores/services.

6. Termination of Contract.

The Buyer shall have the right to terminate this contract in part or in full in any of the following cases :-

6.2. The Seller is declared bankrupt or becomes insolvent.


6.3. The delivery of material is delayed due to causes of force majeure by more than three months provided force majeure clause is included in contract.

2. Risk and Expense Clause

2.1. Should the stores or any instalment thereof not be delivered within the time specified in the Supply Order, or if defective delivery is made in respect of the stores or any instalment thereof, the Buyer shall after granting the Seller 45 days to cure the breach, be at liberty, without prejudice to the right to recover liquidated damages as a remedy for breach of terms and conditions, to declare the transaction as cancelled either wholly or to the extent of such default.


2.2. Should the stores or any instalment thereof not perform in accordance with the specifications/parameters provided by the SELLER during the check proof test to be done in the BUYER's premises, the BUYER shall be at liberty, without prejudice to any other remedies for breach of terms and conditions, to cancel the transaction wholly or to the extent of such default.

2.3. In case of a material breach that was not remedied within 45 days, the BUYER shall, having given the right of first refusal to the SELLER be at liberty to purchase, manufacture, or procure from any other source as he thinks fit, other stores of a similar description to make good:

2.3.1. Such default.

2.3.2. In the event of the contract being wholly determined the balance of the stores remaining to be delivered thereunder.

2.4. Any excess of the purchase price, cost of manufacture, or value of any stores procured from any other supplier as the case may be, over the Supply Order price appropriate to such default or balance shall be recoverable from the SELLER. Such recoveries shall not exceed 40% of the value of the Supply Order.

3. Force Majeure Clause

Should any Force Majeure circumstances arise, each of any stores procured involved in this transaction shall be excused from the non-fulfilment or the delayed fulfilment of any of its occurrence as long as he informs the other party in writing Force Majeure shall mean fires, floods, hurricanes or other acts that are unanticipated or unforeseeable and not brought about at the instance of the party wanting to be affected by such event, or which, if anticipated or foreseeable could not be guarded against. War, embargoes, and civil insurrection shall also be considered within the scope of the clause. A party claiming excuse from performance of any obligation hereunder as a result of the occurrence of any such event shall exercise reasonable diligence to seek to overcome the Force Majeure event and to mitigate the effects thereon of the performance of its obligations under this transaction.

4. Specification

The Seller guarantees to meet the specifications as per Part II of this contract and to incorporate the modifications to the existing design/configuration to meet the specific requirement of the Buyer.

5. Inspection Authority


The inspection will be carried out by the consignee. The mode of inspection will be Departmental Board of Officers.

6. **Warranty:** The following warranty will form part of the contract placed on successful bidder:

6.1. Except as otherwise provided in the invitation tender, the seller hereby declares that the goods, stores articles, sold/supplied to the Buyer under this contract shall be of the best quality and workmanship and new in all respect and shall be strictly in accordance with the specification and particulars contained/mentioned in contract. The seller hereby guarantees that said goods/stores/articles will continue to conform to the description and quality aforesaid for a period of 36 months from the date of delivery/dispatch stores/articles to the buyer or 36 months from the date of installation of the said stores/articles whichever is earlier and notwithstanding the fact that the Buyer may have inspected and/or approved the said goods/stores/articles. If during the aforesaid period of 36 months the said goods/stores/articles be discovered not to conform to the description and quality aforesaid or have deteriorated (and the decision of the Buyer in that behalf will be final and conclusive) the Buyer will be entitled to call upon the seller to rectify the goods/stores/articles or such portion thereof as is found to be defective by the Buyer within a reasonable period, or such period as may be mutually agreed upon and in such an event, the above period shall apply to the goods/stores/articles rectified from the date of rectification thereof. In case of failure of the seller to rectify or replace the goods within a reasonable period, the Buyer shall be entitled to recover the cost of such stores/articles from the seller at the same time to recover compensation as may arise by reason of the breach of the condition.

6.2. Guarantee that they will supply spare parts, if and when required on agreed basis for an agreed price. The agreed basis could be and including but without any limitation an agreed discount on the published catalogue or an agreed percentage off on the landed cost.



7. Performance Bank Guarantee (PBG)

Requirement: A successful bidder is required to provide a Performance Bank Guarantee (PBG). Issuing Authority: The guarantee must be from a Public Sector Bank or a Private Bank authorized to conduct government business. Amount: The sum must be equal to 5% of the supply Order/Contract value. Timeline: It must be furnished within 30 days of receipt of the confirmed order. Validity: The PBG should be valid for at least 60 days beyond the date of warranty. Format: The specimen for the PBG is provided in Form DPM-15, which is available on the MoD website and can also be provided upon request.



PART-V: EVALUATION CRITERIA & PRICE BID ISSUES

1. **Evaluation Criteria.** The broad guidelines for evaluation of bids will be as follows: -

1.1. Only those bids will be evaluated which are found to be fulfilling all the eligibility and qualifying requirements of the RFP, both technically and commercially.

1.2. In respect of Two-bid system, the Technical Bids forwarded by the Bidders will be evaluated by the Buyer with reference to the technical characteristics of the equipment as mentioned in the RFP. The compliance of technical bids would be determined on the basis of the parameters specified in the RFP. The price bids of only those bidders will be opened whose technical bids would clear the technical evaluation.

1.3. As it is a Turnkey Project, the lowest bid will be decided upon the lowest price quoted by the particular bidder as per the Price format given at the Para 3 below.

1.4. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price will be corrected, if there is a discrepancy between words and figures, the amount in words will prevail for calculation of price.

1.5. The lowest acceptable bid will be considered for placement of contract supply order after complete clarification and price negotiation as decided by the Buyer.

2. **Turnkey Project.** The project will be treated as a Turnkey Project and no piecemeal orders for individual items will be placed. The vendor is expected to provide all accessories required for the project to make the project functional and useable without any additional cost to the user.
